The BWA Student Exchange program was first inaugurated in 1971 as one of the approved World Buddhist Women's Convention resolutions. We have sent 34 girls to Japan since then and a similar number of girls have visited Hawaii to foster fellowship and goodwill. In the last newsletter, we announced the selection of two

Approximately one hundred eager participants from Jikoen, Moiliili, Hawaii Betsuin, and Kailua gathered at Hawaii Betsuin the sunny morning of Sat., Sept. 25, to board three buses for the Honolulu United BWA Field Trip to Kailua Hongan-

ji and Kahuku Hongwanji. Honolulu United BWA President, Irene Nakamoto, proposed this field trip to give participants an opportunity to visit Kailua Honganji before its current structure is demolished for construction of a new temple and to visit Kahuku Hongwanji which will be closing its doors permanently in the near future.

The buses traveled over the Pali Highway into Kailua Town and, after a warm welcome at Kailua Honganji, the group lined up for a photo in front of the curtemple they eventually constructed, such evidence of determination and gratitude for the Teachings.

Myra Ikeda gave us all a pat on the back as Buddhist women who are the backbones of our temples and are very strong links in Amida's Golden Chain. She spoke about Project Dana that helps seniors live safely in their own homes. She told us that if we expect to live in compassionate, caring communities, we must each do our part.

We also had special guests, Kiichi Kaya and Toyoko Saeki, who are the grand nephew and niece of Katsu Goto, the 19th century Japanese immigrant who advocated better working conditions for the Japanese plantation workers. Goto's niece, Fumiko Kaya, started a foundation to work towards peaceful understanding between Hawaii and Japan. She was another strong Buddhist woman quietly working within the teachings of the Dharma for peace, compassion and understanding. Patsy Iwasaki, the first recipient of the Kaya Foundation grant, wrote a graphic novel of Katsu Goto in manga format called Hamakua Hero: A
